An in-person visit was condcuted on this date. The Director stated that the program does not provide routine transportation or provide swimming activities. The program was asked to submit Annual Insepection documents in Decal Koala by March 29, 2022.

- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an

# **Activities and Equipment**

## 591-1-1-.12 Equipment & Toys(CR)

**Not Met** 

## Finding

591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined based on observation that the following equipment was hazardous:

- Two round tables in the Back Middle Classroom had loose screws causing the tables to not be stable.
- The cabinet doors in the two-year-old classroom had broken hinges posing a potential tipping hazard.
- One broken handle on the refrigerator door in the Dramatic Play Center of the Back Middle Classroom.
- Large holes with exposed foam were present on the blue soft climber with stars in the Second Left Classroom.
- The cabinet in the one-year-old classroom had peeling pieces of vinyl posing a potential hazard.

#### **POI** (Plan of Improvement)

The broken handle was repaired during the visit. The Director will remove, repair, or replace the soft blue climber. The center will replace or tighten the loose screws on the two round tables in the Back Middle Classroom. The Center will ensure that equipment and furniture are used by the age-appropriate group of children. The Director stated that they would ensure that the broken hinges were repaired and they were planning to replace the cabinet in the one-year-old classroom that had peeling vinyl. The center will continue to monitor all equipment and furniture to ensure that it is free from hazardous conditions and kept clean.

591-1-1-.25(8) - The consultant spoke with the Director about ensuring that all unused electrical outlets are covered with a protective cap to ensure they are inaccessible to the children in care. Four unused electrical outlets were observed with no protective caps in a classroom currently not in use for the day. The Director was able to quickly place protective caps over all the electrical outlets.

## 591-1-1-.26 Playgrounds(CR)

**Not Met** 

#### **Technical Assistance**

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area.

The consultant spoke with the Director about cutting the bolts extending more than two threads observed on the gate between the Left Playground and the Back Playground and the bolts extending more than two threads observed on the gate between the Right Playground and the Back Playground to prevent a potential protrusion hazard. The Director stated that the bolts would be cut down to two threads.

## Finding

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on observation that the following equipment hazards were present on the playground:

- On the Back Playground there were six protruding nails on the flat platform and ten along the outside of the wooden platform.
- On the Left Playground the wooden platform had one protruding nail near the top of the slide.
- On the Back Playground there was one protruding screw under the wooden platform above the wooden benches the children sit at.
- The basketball goal net was torn and not in good repair
- There were three swings per bay on the playground and not two as recommended

## POI (Plan of Improvement)

One swing was removed from each bay during the visit. The Director hammered down protruding nails during the visit and will continue to monitor the wooden platforms to ensure they are in good repair. Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters.

Correction Deadline: 4/1/2022

#### **Finding**

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation that only four-inches of resilient surfacing was observed under the swinging and climbing equipment on the Back Playground and Left Playground and not six-inches as required.

## POI (Plan of Improvement)

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency.

#### Finding

591-1-1-.10(4) requires that if diapers are changed on a diaper changing surface, the surface shall be smooth, nonporous, and equipped with a guard or rails to prevent falls. Between each diaper change, the diaper changing surface shall be cleaned with a disinfectant and dried with a single-use disposable towel. It was determined based on observation that the diaper changing pad in the Infant classroom, First Left Classroom, and Second Right Classroom had holes and tears making the surface porous and not nonporous as required.

## POI (Plan of Improvement)

The Center will ensure there is a smooth, nonporous changing surface that has a guard or rails for safety in each classroom that houses children wearing diapers. Center Staff will be trained and have adequate supplies to properly clean the diaper changing surface between each diaper change.

## Finding

591-1-1-.10(6) requires Center Staff to keep any items which might harm a child out of a child's reach. It was determined based on observation that the changing surface in the Second Right Classroom had a pack of Extra Spearmint Gum and two hair ties posing a potential hazard to the children in care.

## POI (Plan of Improvement)

The Center will remove any harmful item and provide instruction to staff that includes identification and storage of hazardous items and procedures for keeping classrooms and other children's areas free of hazards.

## **Finding**

591-1-1-.30(2) requires the Center to provide a safe sleep environment in accordance with American Academy of Pediatrics (AAP), Consumer Product Safety Commission (CPSC) and American Society for Testing and Materials (ASTM) recommendations as listed in these rules for all infants. Center Staff shall place an infant to sleep on the infant's back in a crib unless the Center has been provided a physician's written statement authorizing another sleep position for that particular infant that includes how the infant shall be placed to sleep and a time frame that the instructions are to be followed. When an infant can easily turn over from back to front and back again, Staff shall continue to put the infant to sleep initially on the infant's back but allow the infant to roll over into his or her preferred position and not re-position the infant. Sleepers, sleep sacks and wearable blankets that fit according to the commercial manufacturer's guidelines and will not slide up around the infant's face may be used when necessary for the comfort of the sleeping infant. Swaddling shall not be used unless the Center has been provided a physician's written statement authorizing its use for a particular infant that includes instructions and a time frame for swaddling the infant. Center Staff shall not place objects or allow objects to be placed in or on the crib with an infant such as but not limited to toys, pillows, quilts, comforters, bumper pads, sheepskins, stuffed toys, or other soft items and shall not attach objects or allow objects to be attached to a crib with a sleeping infant, such as, but not limited to, crib gyms, toys, mirrors and mobiles. It was determined based on observation that one infant was sleeping in a crib with a bib attached to the side of the crib.

#### POI (Plan of Improvement)

The Center will take all steps necessary to provide a safe sleep environment for infants as listed in these rules; will train Staff to follow these rules; and will monitor for compliance.
