Comments

An Administrative Review was conducted on January 21, 2022. Staff files, children's files, training, and background checks were all reviewed. An Initial Licensing Study was conducted on January 25, 2022. The Exit Conference was conducted virtually on January 26, 2022, at 2:30 pm with the director. Permission to Operate will be issued upon completion of the Exit Conference and signature pages are returned to the consultant. Facility does carry Liability Insurance. An updated Certificate of Occupancy is required for the permanent license to be issued.

Plan of Improvement: No Plan Developed

Any rule violation which subjects a child to injury or life-threatening situation or any rule violations previously cited but not corrected, may result in the imposition of an adverse enforcement action. Serious or continued noncompliance may also jeopardize participation in one or more DECAL program(s).

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





Important New Deadlines:

Due to the ongoing COVID restrictions, the deadline to become Quality Rated for programs who want to continue to receive Childcare and Parent Services (CAPS), has been extended to at least December 31, 2021.

The center will add a movable barrier, like a vinyl sliding partition to control odors, aid privacy and provide adequate sanitation measures.

The center will have maintenance add a movable barrier, like a vinyl sliding partition between the toilets in the center.

Finding

591-1-1-.06(7) requires Center Staff to ensure bathrooms are cleaned daily with a disinfectant. It was determined based on the consultant's observation that the toilets throughout the center were stained and some in need of repair. Toilets should be disinfected and monitored daily and repaired as needed.

POI (Plan of Improvement)

The Center will develop and implement a plan to ensure that bathrooms are cleaned and disinfected daily and that this is monitored daily. The center will also have maintenance repair or replace the toilets as needed.

Sleeping & Resting Equipment

A visit was conducted on this date, the consultant observed nine (9) of nine (9) cribs in the Infant Classroom with the manufacturing date, June 2021, used for sleeping and resting, to meet Consumer Product Safety Commission (CPSC) and American Society for Testing and Materials International (ASTM) safety standards. The center will use cots for walking one (1) year old children. The consultant also discussed all Infant Safe Sleeping and Resting requirements with Center Director. Further, the Consultant observed a pleasant nap time environment, and discussed cot and mat disinfecting requirements with Center Director and Owner on this date.
