- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee



Important New Deadlines:

Due to the ongoing COVID restrictions, the deadline to become Quality Rated for programs who want to continue to receive Childcare and Parent Services (CAPS), has been extended to at least December 31, 2021.

It was determined based on the consultant's review of records that the staff member who participated in the transportation of children during the week of April 25, 2021 to April 30, 2021 and for the week of May 3, 2021 to May 7, 2021 did not have evidence of two (2) hours of state-approved or state-accepted transportation training as required.

The Center will ensure that the Director, Center Staff, and any person responsible for the transportation of children has completed the required transportation training.

It was determined based on the consultant's review of records that staff member #6 did not have a valid and current satisfactory Comprehensive Records Check Determination on file. Staff member #6 was observed to be present with children in classroom B during the virtual inspection.

The Comprehensive Records Check Determination must have a Records Check Clearance Date that is no older than the preceding 12 months of the hire date; provided, however, if the Employee has had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, a new satisfactory Comprehensive Records Check Determination is required. The program's owner or an officer/member of the corporation must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The center will ensure the CRC rules are maintained.
