- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





# Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

- -There were two cleaning spray solutions in the portable sink.
- -There was a broom, dust pan, and dusting mop in the bathroom.
- -There was a pack of Cuties diapers on the floor.
- -There was a bucket containing packs of wipes on the bathroom floor.

#### 1st Right

-There was an unlocked cabinet containing air freshener, vaseline, diaper cream, Aquaphor, two packs of Cuties diapers, and plastic bags.

# 2nd Right:

- -There was a broom, dust pan, and dusting mop in the bathroom.
- -There was a large rug rolled up behind the diaper changing table.
- -There was a staff bag on the back shelf.

### POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

### **Finding**

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on observation that the flooring throughout the center was not kept clean.

It was determined based on a review of files that there were no infant feeding plans for two of four enrolled infants. It was further determined based on a review of files that two of four infant feeding plans were incomplete and had not been updated since April 2022.

# **POI** (Plan of Improvement)

The Center Director will develop and implement a plan to obtain and post the completed feeding plan as part of the enrollment process and to have parents update the plans on a regular basis that will include center staff involved with enrollment and those working in the infant classrooms.

# **Finding**

591-1-1-1.14(2) requires a Staff member who is trained in CPR and first aid to be on the premises and on any field trip whenever any child is present. In addition, Staff who provide direct care to children must satisfactorily obtain certification in first aid and CPR by December 29, 2016 if employed prior to September 30, 2016 and within 90 days of their hire date if employed after September 30, 2016. It was determined based on a review of staff files that staff #1, staff #2, staff #3, staff #4, staff #6, staff #7, staff #11, staff #13, and staff #14, did not have evidence of having completed first aid and CPR.

# POI (Plan of Improvement)

The Center will develop a schedule to ensure there is always a staff person with current first aid and CPR training present and will develop and implement a plan to ensure all staff members have satisfactorily completed first aid and CPR training by the specified date.

591-1-1-.33(1) requires all Employees and Provisional Employees to receive Initial Center orientation prior to assignment to children or task. It was determined based on a review of records that staff #11 hired on April 19, 2022 and staff #13 hired on April 18, 2022 did not have evidence of having completed center orientation.

# **Finding**

591-1-1-.33(3) requires each Staff member with direct care responsibilities to complete health and safety orientation training within the first 90 days of employment. The state-approved training hours obtained will count toward required first year training hours. The training must address the following health and safety topics: prevention and control of infectious diseases (including immunizations); prevention of sudden infant death syndrome and use of safe sleeping practices; administration of medication, consistent with standards for parental consent; prevention of and response to emergencies due to food and allergic reactions; building and physical premises safety, including identification of and protection from hazards that can cause bodily injury such as electrical hazards, bodies of water, and vehicular traffic; prevention of shaken baby syndrome, abusive head trauma and child maltreatment; emergency preparedness and response planning for emergencies resulting from a natural disaster or a human-caused event (such as violence at a child care facility); handling and storage of hazardous materials and the appropriate disposal of bio contaminants; precautions in transporting children; recognition and reporting of child abuse and neglect; and child development. It was determined based on a review of staff files that the following staff did not complete the health and safety orientation training within the first 90 days of employment:

- -Staff #1 hired on August 4, 2022
- -Staff #2 hired on July 11, 2022
- -Staff #3 hired on August 1, 2022
- -Staff #7 hired on August 1, 2022

### **POI** (Plan of Improvement)

The Center will develop and implement a plan to schedule and track this training for all employees based on their hire dates and will ensure that the training includes all required components as required.
