- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





#### Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

### A-1st Right-

•A staff purse, broom and dust pan were in an unlocked closet.

•Four pairs of scissors, an Energizer "C" battery, and a roll of white out were in an unlocked drawer. •Two boxes of gloves, a trash bag, 12 Alcohol prep pads, 2 Antiseptic Towelettes, four packs of Medique Diphen tablets, two packs of Non Aspirin tablets, and a pack of burn gel was in an unlocked drawer under the diaper changing table.

•A toilet brush was in the bathroom.

#### D-3rd right-3 y/o

•A broom and dust pan were in the corner by the toy shelf.

•Three packs of Pampers Sensitive baby wipes, one pack of Pampers baby wipes, one pack of Pinkfrog Baby Shark baby wipes, and a pack of Parents Choice Sensitive baby wipes were in children's cubbies.

#### F-3rd Left-End-5+

•A box of gloves, a container of Equate Petroleum Jelly, and a bottle of Ultra Defense Sanitariums Hand Sanitizer was on a low shelf.

H-new room

•Two packs of Babysoft baby wipes and a container of Equate Petroleum Jelly was in a child's cubby.

#### POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

#### Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based upon observation that there was a potential entrapment hazard on the Large Playground when there was a five inch gap from the ground to the bottom of the wooden fence on the left side fence. It was further determined that there was also a three inch by seven inch hole in the wooden fence on the left side fence. It was further determined that the back wooden fence on the Small playground was leaning into the playground on the left and right side.

For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based upon observation that two out of four tricycle seats were cracked on this date.

#### POI (Plan of Improvement)

The Center will provide a variety of age-appropriate equipment that is arranged so as not to obstruct supervision of children. Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters.

591-1-1-.36(7)(c)2. requires that the driver or other designated person shall immediately document in writing, with a check or other mark/symbol to account for each child listed on the passenger transportation checklist each time a child enters and exits the vehicle. The driver or other designated staff person shall document in writing with a different mark/symbol to account for each child listed on the passenger transportation checklist who was not present on the vehicle for any reason. An explanation shall be documented in writing whenever a child is transported to a field trip site but is not present on the return trip to the Center. It was determined based upon a review of records that one child was not marked load or unload on the transportation record for the field trip to the Georgia Aquarium on July 19, 2022.

The driver/other designated person will immediately document in writing with a check/mark/symbol each time a child gets on and off the vehicle.

591-1-1-.09(1)(j) requires that for portability for Directors, Employees and Provisional Employees, excluding Students-in-Training, only the most recently issued determination letter is eligible for portability and must be ported electronically. A Center may accept a satisfactory Fingerprint Records Check Determination letter or a satisfactory Comprehensive Records Check Determination letter issued by the Department if the Records Check Clearance Date is within the preceding 12 months from the hire date, the individual has not had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, and the Center does not know or reasonably should not know that the individual's satisfactory status has changed. It was determined based upon observation that the center failed to electronically port the most recently issued determination letter.

## POI (Plan of Improvement)

IMMEDIATE CORRECTION - The Center will watch the videos to ensure that only the most recently issued determination letter is electronically ported for Directors, Employees and Provisional Employees, excluding Students-in-Training. A Center may accept a satisfactory Fingerprint Records Check Determination letter or a satisfactory Comprehensive Records Check Determination letter issued by the Department if the Records Check Clearance Date is within the preceding 12 months from the hire date, the individual has not had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, and the Center does not know or reasonably should not know that the individual's satisfactory status has changed. The program's owner or an officer/member of the corporation must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The Center will watch the videos to ensure CRC rules are maintained.
