- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based upon observation that the following hazards were observed accessible to children:

#### Back Classroom:

•A pack of Huggies Natural Choice baby wipes, a pack of Parents Choice Cucumber baby wipes, a pack of Parents Choice Flushable wipes, and a pack of Huggies baby wipes were on a shelf under the diaper changing table.

#### Left Classroom:

•A pack of Huggies Natural Care baby wipes, a pack of Parents Choice Fragrance Free baby wipes, two packs of Pampers baby wipes, a pack of Huggies Simply Clean baby wipes, a pack of Huggies Nourish and Care baby wipes, and two packs of Parents Choice Shea Butter baby wipes were on a shelf under the diaper changing table.

#### Middle Classroom:

•A staff purse and a pair of adult scissors were on a table.

#### Left Classroom:

- •A bottle of hand sanitizer was attached to a child's book bag.
- •A pack of Lysol Disinfecting wipes, a pack of Aquarelle Antibacterial wipes, two packs of Parents Choice Shea Butter wipes, a pack of Huggies with Aloe and Vitamin E, and a pack of Parents Choice Flushable wipes were in a cubby.
- •Two staff bags, a vacuum, a roll of trash bags, and a power strip were in an unlocked cabinet.
- •A plunger, a toilet brush, and a pack of Parents Choice baby wipes were in the bathroom.

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

#### **Finding**

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based upon observation that the back fence was 3 feet six inches tall on the right side when four feet is required.

# POI (Plan of Improvement)

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The Center will train Staff to identify and report any fence hazards and to keep the fence gates closed when not in use.

## **Finding**

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based upon observation that there was one active ant bed by the basketball court and on the right side of the Back Play Yard. It was further determined that a rope and pile of brush was in a pile in the back middle of the Back Play Yard. It was also determined that the shed at the back right of the Back Play Yard had a missing door that was located on the ground on the left side of Back Play Yard.

# POI (Plan of Improvement)

The Center will remove any litter and fix or remove hazards from the playground and will routinely monitor the playground and remove litter and hazards.

It was determined based upon observation that two infants were asleep in swings in the Left Classroom.

# POI (Plan of Improvement)

The Center will only place infants in safe cribs to sleep and will transfer them to a safe crib when the infants are asleep in other equipment.

591-1-Ī-.32(1) requires the Center to maintain the required Staff:child ratios as follows: under 1 year or under 18 months if not walking = 1:6; 1 year and walking = 1:8; 2 years = 1:10; 3 years = 1:15; 4 years = 1:18; 5 years = 1:20; and 6 years and older = 1:25. A Center must establish groupings of children for care with maximum group sizes as follows: under 1 year = 12; under 18 months/not walking = 12; 1 year and walking = 16; 2 years = 20; 3 years = 30; 4 years = 36; 5 years = 40; and 6 years and older = 50. It was determined based upon observation that the Middle Classroom had a Ratio of 1:18 during the Consultant's arrival when a ratio of 2:18 was required.

## POI (Plan of Improvement)

The Center will hire additional Staff or reschedule current Staff to meet required Staff:child ratios and will organize children into groups that meet requirements.
