- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. Finding

290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. It was determined based on observation that the following hazards were observed on the playground on this date:

- Six bolts measuring over two threads were facing inside the playground located on the front left gate.
- Three and a half loose bricks were located inside a concrete planter located in front of the front middle fence.
- Two rail road ties were located inside a concrete planter located in front of the front middle fence.
- Four loose bricks were on ground to the left of the concrete planter.
- Thorny leaves protruding through the fence were located on the front right side of the fence.
- Two exposed tree roots were located to the left of the wooden barrier play area.
- The wooden barrier around the play equipment was splintered at the front left edge.
- One hose connected to a sprinkler tripod was located from the back porch to the middle of the yard.
- One unlit citronella candle and two cans of Off! Family Care Smooth and Dry Insect Repellent were located on the small table between the two rocking chairs.
- One rusted metal grilling spatula was located on the ground in front of the two rocking chairs.

POI (Plan of Improvement)

The Home will repair any and all identified outdoor hazards and will monitor playground daily or more often as needed to ensure that the Home's outdoor play area is kept clean and free of hazards.

Finding

290-2-3-.13(2)(d) requires that outside play areas be protected from traffic or other hazards by fencing or other barriers at least four feet in height and approved by the Department. Fencing material shall not present a hazard to children. A fence shall be provided around swimming pools to make them inaccessible when not in use. It was determined based upon observation that the following sections of the fencing did not measure four feet as required on this date:

- The front left fencing measured at three feet and nine inches.
- The front middle fencing measured at three feet and ten inches.
- The back left fencing measured at three feet and six inches.
- The back middle fencing measured at three feet and five inches.
- The right middle fencing measured at three feet and five inches.

POI (Plan of Improvement)

The Home will enclose the outside play area(s) with a four-foot high fence or other Department-approved barrier and inspect regularly to ensure fencing material is safe and any hazards identified are repaired or replaced. The Home will install or repair a fence around swimming pools that makes them inaccessible to children.
