- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
  - New clearance is required at least once every five years
  - Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
  - All staff members are required to have completed at least a national fingerprint based clearance check
  - Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
  - Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

It was determined based on a review of records that the Center did not ensure that every Employee had a valid and current satisfactory Comprehensive Records Check Determination on file prior to being present at the Center as staff person #12 who was observed present at the center working in the front office, had a Comprehensive Records Check Determination that has expired on July 1, 2022. A one-day letter was left on this date.

The center will ensure the CRC rules are maintained.

### Finding

591-1-1-.09(1)(I)3. requires the Center to immediately require a new Comprehensive Records Check Determination for a Director, Employee or Provisional Employee at least once every five years. It was determined based on a review of records that the Center did not immediately require a new Comprehensive Records Check Determination at least once every five years for staff person #12 as they were noted to have a Comprehensive Records Check Determination that had expired on July 13, 2022. A one day letter was left on this date.
