

Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based upon observation that there was a three inch hole at the back left corner of the wall in the bathroom of the Second Right Classroom. It was further determined that the toilet paper dispenser in the bathroom of the Second Right Classroom was not secured to the wall. It was also determined, there were four sections of peeling paint in the Second Right Classroom.

Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based upon observation that there was a four inch gap from the ground to the fence in the middle of the back fence on the Left Playground. It was also determined that there was a four inch gap and a four and a half inch gap from the ground to the fence at the middle of the left side fence of the Back Playground.

For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based upon observation that four out of ten tricycles were missing handle bar grips.

It was determined based upon observation that staff failed to ensure children washed hands after diapering in the Second Left Classroom. It was further determined that staff in the Second Right Classroom failed to ensure that two children washed hands immediately upon arrival.
