The purpose of this visit was to conduct a Monitoring visit and to follow up to the previous visit conducted on February 28, 2022. Staff files and background checks were all reviewed. A virtual inspection was conducted on March 31, 2022 with the Director, Cyndi Virgilio. An in-person visit was not conducted due to the COVID-19 pandemic.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

# 591-1-1-.36 Transportation(CR)

#### Comment

Consultant observed completed checklists with arrival times, departure times, and first and second vehicle checks documented.

#### Finding

591-1-1-.36(7)(b) requires that an emergency medical information record be maintained in the vehicle for each child being transported. The emergency medical information record for each child shall include a listing of the child's full name, date of birth, allergies, special medical needs and conditions, current prescribed medications that the child is required to take on a daily basis for a chronic condition, the name and telephone number of the child's doctor, the local medical facility that the Center uses in the area where the Center is located and the telephone numbers where the Parents can be reached. It was determined based on a review of records that three of fourteen emergency medical forms did not include allergies, special medical needs and conditions, and two of fourteen records did not include the name and telephone number of the child's doctor. Further review of records revealed that the center did not have an emergency medical form on file for one of fourteen children that receive school transportation services.

#### POI (Plan of Improvement)

The Center will obtain a complete emergency medical information record for each child that is transported and maintain a copy on the vehicle.

Before a change of occupant, each mattress shall be cleaned with a disinfectant. It was determined based on observation that several gaps were observed in the corners between the mattress of one crib located in classroom 1L.

#### POI (Plan of Improvement)

The center will ensure that a crib mattress is firm, tight-fitting without gaps, at least 2 inches thick and covered with a waterproof, washable material.
