#### **Comments**

The purpose of this visit was to conduct a Monitoring visit. This visit was conducted in person by the consultant on August 4, 2022.

An Administrative Review was uploaded and completed by the consultant on August 9, 2022. All requested documents were submitted.

An Exit conference discussing the Montoring visit report was conducted on August 9, 2022. Consultant emailed the Monitoring Report to Provider for signature and to be returned to the consultant within two business days.

The playground was not observed on this date due to storm damage from a tree falling. Provider was in the process of having fallen tree removed. Pictures were sent to the consultant.

No children were present during the visit, due to Provider having an appointment.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an
  employee





#### Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.
