#### Important Quality Rated/CAPS Update:

In no case, however, shall a new owner operate the Center without first securing a new License or Permit from the Department. It was determined based on observation that room B 1 Left had a wall removed but an application for an Amendment was not submitted. Additionally, the playgrounds need to be added with an amendment application.
