

3) Select the specific rule number(s) that you are refuting, add the reason for disagreement regarding the rule citation, and upload supporting documentation

4) Submit the refutation in DECAL KOALA to Child Care Services (CCS) within 10 business days of the completion date.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)





#### Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

\* Building C (Front room) - Aquaphor cream, labeled, "Keep out of reach of children" was located under the diaper changing table. Additionally, Febreeze and hand sanitizer was located on top of the counter near the changing table.

\* Main building (Room A) - Baby wipes in a pink and purple backpack inside a cubby on the right side of the classroom.

\* Main building (Room A) - Hand sanitizer, labeled "Keep out of reach of children" was located near the sink on the right side of the classroom.

\* Main building (Room A) - Dawn dish spray, labeled "Keep out of reach of children" was located near the sink on the right side of the classroom.

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation that the fence on the left, right and rear near the parking did not measure (4) feet high but measured (3) feet (11) inches. Additionally, the fence located in the back rear had a gap underneath that measured approximately seven inches which was an entrapment hazard.
