## Findings:

General: Based on observation, the surveyor found the following:

- 1. The Indoor Gross Motor area had fish poles with no hooks and an outdoor canopy being stored.
- 2. The Over Flow School-Age Classroom had at least ten (10) totes and five (5) computer printers being stored.

Staff reported that she would have the rooms cleaned.

## 922 KAR 2:120. Section 4. Premises Requirements.

- (1) The premises shall be:
- (a) Suitable for the purpose intended;
- (b) Kept clean and in good repair;

#### Findings:

General: Based on observation, the surveyor found the following:

- 1. The air conditioner vent located in the Infant Classroom had a heavy accumulation of dust.
- 2. The exhaust vent in the boys' restroom had a heavy accumulation of dust.
- 3. The door trim was propped against the wall exposing the nails in the Toddler Classroom. During interview, staff reported that the door trim fell when someone opened the door.
- 4. One side of the rug located in the After-School Classroom had rolled up.

Staff reported that she would have the areas listed above cleaned and repaired.

#### 625 - Floors, Walls, Ceilings

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

#### Findings:

General: Based on observation, the surveyor found the following:

- 1. There was about a two (2) inch by four (4) inch area where the tile was missing, exposing the subflooring in the boys' restroom.
- 2. There was an approximately two (2) inch by three (3) inch area that appeared to be drywall exposed located in the boys' restroom.
- 3. There were four (4) cracks around the exhaust vent in the ceiling tile located in the boys' restroom.
- 4. There were seven (7) ceiling tiles that contained a brown substance located in the After-School Classroom.
- 5. There was an inch by inch hole in the drywall by the exit door located in the After-School Classroom.

Staff reported that she would have the items listed above repaired.

# 922 KAR 2:120. Section 12. Toilet, Diapering, and Toiletry Requirements.

- (4) Each toilet shall:
- (a) Be kept in clean condition;
- (b) Be kept in good repair;
- (c) Be in a lighted room; and

# Findings:

General: Based on observation, the surveyor discovered the toilet seat was not securely attached to the toilet bowl in the girls' restroom.

Staff reported that she would have the seat repaired.

General: Based on observation, the surveyor found a paper type substance on the playground.

Staff reported that she would have the playground cleaned.

835 - Crib/Mattress/Sheet Not In Compliance

## 922 KAR 2:120. Section 6. Sleeping and Napping Requirements.

- (3) Rest time shall occur in an adequate space according to the child's age as follows:
- (a) For an infant:
- 1. An individual non-tiered crib that meets Consumer Product Safety Commission standards established in 16 C.F.R. 1219-1220;
- 2. A firm crib mattress in good repair with a clean tight-fitted sheet that shall be changed:
- a. Weekly; or
- b. Immediately if it is soiled or wet;

#### Findings:

General: Based on observation, the surveyor discovered that there were two (2) crib mattresses in the nursery that were ripped on the edge; therefore, the crib mattresses were not in good repair.

Staff reported that she would have the crib mattress' replaced.
