Findings:

General: Based on observation, the surveyor observed the following:

- 1. A thick coating of dirt and debris was located on the blue rug in the Bigger One Year Old Classroom; therefore, the blue rug was not kept clean.
- 2. A thick coating of dirt and debris was located on the carpet in the Nursery Classroom; therefore, the carpet was not kept clean.
- 3. A thick coating of dirt and debris was located on the paint rug in the Smaller One Year Old Classroom; therefore, the paint rug was not kept clean.
- 4. A thick coating of dirt and debris was located on the blue rug in the Smaller One Year Old Classroom; therefore, the blue rug was not kept clean.
- 5. The ceiling contained what appeared to be a brown stain and crack on the ceiling in the hallway; therefore, the ceiling was not in good repair.
- 6. A thick coating of dust on the air vent in the Nursery Classroom; therefore, the air vent was not kept clean.

Staff reported she would have the rugs and air vent cleaned. Staff stated that a maintenance order has been completed for the ceiling to be repaired.

General: Based on observation, the surveyor observed the following:

- 1. A yellow substance was located in the toilet bowl in the restroom. The restroom was located near the School Age Classroom.
- 2. A toilet seat was not securely tighten to the toilet in the restroom located near the Two Year Old Classroom.

Staff reported she would talk to staff about flushing the toilets and she would have the toilet seat repaired.

- 1. Holes were in the diaper changing pad located in the Two Year Old Classroom; therefore, the diaper changing pad was not in good repair.
- 2. Holes were in the diaper changing pad located in the Bigger One Year Old Classroom; therefore, the diaper changing pad was not in good repair.
- 3. Holes were in the diaper changing pad located in the Nursery Classroom; therefore, the diaper changing pad was not in good repair.

Staff reported she would replace the diaper changing pads.

- 1. There was not an adequate amount of protective surface (mulch) around the slides and climbing structures on the small playground.
- 2. There was not an adequate amount of protective surface (mulch) around the slides and climbing structures on the bigger playground.

Staff reported she would notify the director.

- 1. There were two (2) sleeping mats located in the School Age Classroom that contained tears; therefore, the sleeping mats were not in good repair.
- 2. A futon mattress located in the School Age Classroom contained a rip in the cover; therefore, the futon mattress was not in good repair.

Staff reported she would let the director know about the issues with the sleeping mats and the futon mattress.
