Findings:

General: Based on review of documentation and interview, the child care center director failed to assure compliance with regulatory requirements with regard to staff meetings. Upon request, the child care center director did not provide documented evidence that staff meetings were conducted during the review period.

- (j) Assess each staff person's interaction with children in care and classroom performance through an annual written performance evaluation;

Findings:

General: Based on review of documentation and interview, the child care center director failed to assure compliance with regulatory requirements with regard to staff evaluations. Upon request, the director failed to provide documented evidence of an annual written performance evaluation/assessment, conducted during the review period, for staff with hire dates 12/08/12, 08/25/16, 08/01/13 and 09/01/09.

General: Based on review of documentation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Upon request, the child care center director failed to provide documented evidence of a high school diploma, GED, qualifying documentation from a comparable educational entity or Commonwealth Child Care Credential for staff with a hire date 08/01/18.

395 - TB Verification Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
- . A statement from a health professional that the individual is free of active tuberculosis; or

Findings:

General: Based on review of documentation and Interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Upon request, the child care center director failed to provide documented evidence of a statement from a health professional that staff with hire dates 08/01/18 and 08/25/16 are free of active tuberculosis.

410 - Training **Not In Compliance**

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 1/2) hours of cabinet-approved pediatric abusive head trauma training; and

General: Based on review of documentation and Interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Upon request, the child care center director failed to provide documented evidence of one and one-half (1 1/2) hours of cabinet approved pediatric abusive head trauma training completed once every five (5) years for staff with hire dates 08/01/14 and 08/01/13.

Findings:

General: Based on review of documentation and interview, the child care center failed to maintain written documentation in accordance with regulatory requirements. Upon request, the child care center director failed to provide documented evidence that the child care conducted monthly fire drills and quarterly earthquake and tornado drills detailing the date, time and children who participated, for the for the current review period.

1195 - Fire Drills Not In Compliance

922 KAR 2:120. Section 3. General Requirements.

- (12) A fire drill shall be:
- (a) Conducted during hours of operation at least monthly; and
- (b) Documented.
- (13) An earthquake drill and a tornado drill shall be:
- (a) Conducted during hours of operation at least quarterly; and
- (b) Documented.

Findings:

General: Based on review of documentation and interview, the child care center failed to maintain written documentation in accordance with regulatory requirements. Upon request, the child care center director failed to provide documented evidence that the child care conducted monthly fire drills and quarterly earthquake and tornado drills for the current review period

- 1. The animal is under the supervision and control of an adult;
- 2. Written parental consent has been obtained; and
- 3. The animal is certified as vaccinated against rabies; or
- (b) Except in accordance with subsection (3) of this section.

Findings:

General: Based on observation, review of documentation and interview, the child care center failed to comply with regulatory requirements with regard to animals in the area of care of children. Observation of the Pre-Kindergarten classroom Room 140 revealed fish in a fish bowl in the reach of children. Upon request, the child care center director did not provide documented evidence of parental consent for each child's presence in the classroom with the fish.
