General: Based on Review of Documentation, it was determined the provider failed to comply with certification standards regarding provider records, specifically provider CPR/First Aid. The provider failed to provide documentation at time of survey verifying she is currently certified by an agency approved in accordance with 922 KAR 2:240 in infant and child cardiopulmonary resuscitation (CPR).

The provider failed to provide documentation at time of survey verifying the completion of at least nine (9) hours of cabinet-approved early care and education training annually.

General: Based on Observation, and review of documentation, it was determined the provider failed to comply with certification standards regarding provider records, specifically assistant CPR/FA. At 2:05 p.m. observation revealed a staff member self-identified as the assistant, alone in the home supervising the children. The provider failed to provide documentation at time of survey verifying that the assistant is certified by a cabinet-approved agency in infant and child cardiopulmonary resuscitation (CPR) and first aid.
