- (e) Manage the staff in their individual job descriptions:
- (f) Develop child-care center plans, policies, and procedures;
- (g) Supervise staff conduct to ensure implementation of program policies and procedures;

Findings:

General: Based on interview, a caregiver, hired 3/15/13 placed a child on a rest mat in the restroom for approximately forty-five (45) to sixty (60) minutes when the child was disruptive during nap time. The exact dates of the incident were unknown. The center's policy indicated caregivers will use redirection and time out briefly to modify children's

Findings:

General: Based on interview, a child enrolled 4/23/14, screamed and cried for approximately forty-five (45) to sixty (60) minutes during nap time. This child's mat was placed in the restroom and the child was required to remain in the restroom until she stopped crying or fell asleep.

Programming

375 - Waiting Period **Not In Compliance**

922 KAR 2:120. Section 2. Child Care Services.

- (8) A child shall not be required to stand or sit for a prolonged period of time:
- (a) During an activity:
- (b) While waiting for an activity to start; or
- (c) As punishment.

Findings:

General: Based on interview, a child enrolled 4/23/14, was placed on a nap mat in the restroom for approximately forty – five (45) minutes to sixty (60) minutes when the child was disruptive during nap time.

385 - Discipline **Not In Compliance**

922 KAR 2:120. Section 2. Child Care Services.

- (10) A child shall not be subjected to:
- (a) Corporal physical discipline pursuant to KRS 199.896(18);
- (b) Loud, profane, threatening, frightening, or abusive language; or
- (c) Discipline that is associated with:
- 1. Rest;
- 2. Toileting; or
- 3. Food.

Findings:

General: Based on interview, a child enrolled 4/23/14, would not go to sleep during nap time, was disruptive to the other children and cried when returned to the child's mat. A caregiver hired 3/15/13, placed this child and her mat in the restroom for approximately forty-five (45) to sixty (60) minutes on unknown dates.

445 - Rest Period - Alternate Activity

(5) A child who does not sleep shall be permitted to play quietly and shall be visually supervised.

General: Based on interview, a child enrolled 4/23/14, was required to remain on a rest mat during nap time, even though the child did not sleep. The child lay on a nap mat, cried and screamed for approximately forty-five (45) to sixty (60) minutes and was not given an alternate activity.
