- (b) Shall provide, prior to employment and every two (2) years thereafter:
- 1. A statement from a health professional that the individual is free of active tuberculosis; or
- 2. A copy of negative tuberculin results.

Findings:

General: Based on Review of Documentation, a caregiver hired on 08/14/17, had no TB documentation on file.

410 - Training Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 $\frac{1}{2}$) hours of cabinet-approved pediatric abusive head trauma training; and

Findings:

General: Based on Review of Documentation and interview, caregivers hired 07/20/13, 10/05/14 and 02/03/14, failed to complete fifteen (15) hours of cabinet approved training hours during their subsequent year of employment. Also, a caregiver hired 05/22/17, completed seven and one-half (7 1/2) hours of the cabinet approved training hours during their subsequent year of employment. In addition, a caregiver hired 03/19/18 and a caregiver hired 04/09/18, had no proof they completed six (6) hours of orientation training within the first three (3) months of their employment.

General: Based on Observation and interview, a caregiver's cell phone was placed on top of the desk in the infants' room and a caregiver's cell phone was placed on the sink, in the one-year-olds' room accessible to children.

580 - Floors, Walls, Ceilings Not In Compliance

922 KAR 2:120. Section 4. Premises Requirements.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on Observation, the wall and baseboards had peeling and chipped paint in the two-year-olds' room.

- 6. Free of any items not used for diaper changing.

Findings:

General: Based on Observation, the changing pad, in the two-year-olds' room, had a one inch tear on the surface and foam was exposed.
