Findings:

340 - Training

General: Based on Review of Documentation, the surveyor found that five (5) staff (hire date: 8/9/13) did not complete the six (6) hour orientation training within the ninety (90) day timeframe. The staff person in charge stated that the staff are scheduled to take the training in December.

345 - Driver Requirements
