Findings:

General: Based on Observation, and interview, this regulatory requirement was not met. Upon arrival (9:15AM) the surveyor observed seven (7) children (age range: infant - three (3) years old) in the infant classroom with one (1) staff person. The staff person working in the classroom identified four (4) of the children present as infants, one (1) child as a one (1) year old, one (1) child as a two (2) year old and one (1) child as a three (3) year old. The surveyor entered the infant classroom at 9:20AM to conduct an inspection of the area. At this time the staff person working in the classroom moved the two (2) year old child that was present over to the front gross motor area where the rest of the two (2) year old group was playing. The staff person stated, "The two (2) year old child was recently dropped off and needed to eat breakfast, so she ate in my room before joining her group". The staff person stated that the three (3) year old child present has a hard time transitioning and often comes in to visit her after going to the bathroom down the hall. The staff person in charge came in to the infant classroom at 9:30AM and escorted the three (3) year old child to the preschool classroom. Therefore, the infant classroom was out of compliance with staff/child ratios from at least 9:15AM - 9:30AM.

115 - Reports to Cabinet

 3. Criminal records check for any previous state of residence completed once if:
 - a. The adult resided outside the state of Kentucky in the last five (5) years; and
 - b. No criminal records check has been completed for the adult's previous state of residence. The check shall indicate that the adult has not been convicted of, or has not entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in subparagraph 1 of this paragraph; and
 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

155 - Staff Awake on Duty

- (a) For the duration of the family-in-need-of-services assessment or investigation; and
- (b) Pending completion of the administrative appeal process for a cabinet substantiation of child abuse or neglect in accordance with 922 KAR 1:320 or 922 KAR 1:480.

225 - Sick Child Exclusion

(2) A child showing signs of an illness or condition that may be communicable shall not be admitted to the regular child-care program.

General: Based on Review of Documentation, it was found that there was no evidence of staff meetings.

260 - Staff Evaluation

Not In Compliance

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.

(1) Effective with the adoption of this administrative regulation, a director shall:

- (j) Assess each staff person's interaction with children in care and classroom performance through an annual written performance evaluation;

Findings:

General: Based on Review of Documentation, three (3) staff (all hired 8/2/13) eligible for an annual performance review did not have documentation of a review on file in the facility.

(1) Effective with the adoption of this administrative regulation, a director shall:

- (l) Provide for the health, safety, and comfort of each child;

Findings:

General: Based on Observation, the following was found: 1. The preschool classroom contained a rotating fan that was turned on and accessible to the children in the classroom. The fan was sitting on top of a classroom table. 2. The two (2) year old classroom had a radio sitting on top of a Step 2 plastic kitchen set. The radio was plugged in to an electrical outlet in the children's play area. The cord was observed hanging loose and was accessible to the children.

270 - Parent Notification

In Compliance

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.

(1) Effective with the adoption of this administrative regulation, a director shall:

- (m) Notify the parent immediately of an accident or incident requiring medical treatment of a child;

275 - Caregiver Alone

(1) Effective with the adoption of this administrative regulation, a director shall:

- (n) Assure that a person acting as a caregiver of a child in care shall not be left alone with a child, if the licensee has not received the results of the background checks as described in Section 3(1)(e)6 of this administrative regulation;

280 - Altered/Falsified Records

(1) Effective with the adoption of this administrative regulation, a director shall:

- (o) Assure each mandatory record specified in Section 3 of this administrative regulation has not been altered or falsified;

285 - Parental/Family Involvement Activity

(1) Effective with the adoption of this administrative regulation, a director shall:

- (p) Coordinate at least one (1) annual activity involving parental or family participation.

Findings:

General: Based on Review of Documentation, it was found that there was no evidence of a family involvement activity.

Employee Records

300 - Background checks/left alone

Not In Compliance

922 KAR 2:090. Section 6. License Issuance.

(5) An individual described in subsection (4) of this section shall:

- (a) Submit to background checks described in paragraph (b) of this subsection;
- (b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:
 - 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - 2. Criminal records check required by KRS 199.896(19);
 - 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 - 4. An address check of the Sex Offender Registry; and
- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, the following was found: 1. Two (2) staff (both hired 9/8/14) did not have evidence or results of a criminal records check (CRC) on file. 2. One (1) staff person (hire date: 12/5/13) had a CRC that was dated 12/18/13 and a second staff person (hire date: 3/31/14) had a CRC that was dated 5/1/14. There was no documentation to verify that these CRC's were submitted within the regulatory timeframe.

305 - Background checks/discharged

(6) Upon completion of background checks described in subsection (4)(b) of this section, a licensee shall discharge immediately:

- (a) An individual whose name is listed on the central registry established by 922 KAR 1:470;
- (b) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, a crime in accordance with KRS 17.165;
- (c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
- (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
- (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
- (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
 - (a) Nature of the offense;
 - (b) Length of time that has elapsed since the event; and
 - (c) Individual's life experiences after conviction, Alford plea, or guilty plea.

310 - Personnel File

 - d. Number of clock hours completed;
 5. Every two (2) years, a:
 - a. Statement from a health professional that the individual is free of active tuberculosis; or
 - b. Copy of negative tuberculin results; and
 6. For a director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care, the results of a:
 - a. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - b. Criminal records check required by KRS 199.896(19);
 - c. Criminal records check from any previous state of residence completed once if:
 - (i) The individual resided outside the state of Kentucky in the last five (5) years; and
 - (ii) No criminal records check has been completed for the individual's previous state of residence; and
 - d. An address check of the Sex Offender Registry;

315 - Educational Requirements

922 KAR 2:110. Section 5. Staff Requirements.

- (1) Child-care center staff:
- (a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:
1. High school diploma;
 2. GED or qualifying documentation from a comparable educational entity; or
 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

Findings:

General: Based on Review of Documentation, one (1) staff person (hire date: 9/8/14) did not have educational documentation on file.

320 - TB Verification

Not In Compliance

922 KAR 2:110. Section 5. Staff Requirements.

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
1. A statement from a health professional that the individual is free of active tuberculosis; or
 2. A copy of negative tuberculin results.

Findings:

General: Based on Review of Documentation, the following was found: 1. Two (2) staff (both hired 9/8/14) did not have T.B. documentation on file. 2. One (1) staff person did not have evidence of a negative T.B. skin test or physician's statement documenting he/she was free from tuberculosis prior to employment. The staff person was hired on 3/31/14; however, did not have a T.B. skin test until 4/2/14.

325 - CPR/First Aid Coverage

In Compliance

922 KAR 2:110. Section 5. Staff Requirements.
