**Findings:**

General: Based on interview and record review, it was found that a staff person witnessed another staff person slap a 21-month-old child on the cheek in the Ones classroom on 11/22/19. The staff person stated that she was walking to the Ones classroom to assist in diaper changing when she saw another staff person strike the child. She indicated that the other staff person was sitting in a chair with her back to the half-door when the child tried to get between her and a shelf. The staff person stated that the other staff person grabbed the child by the arm and slapped the child on the cheek. She reported that the child began to cry and his cheek was red. She said that when she entered the room, she asked the other staff person why the child was crying and why his cheek was red. She indicated that the other staff person said that the child was slapping himself in the face because he was angry.
