922 KAR 2:120. Section 4. Premises Requirements.
(1) The premises shall be:
(a) Suitable for the purpose intended;
(b) Kept clean and in good repair;

Findings:

General: Based on Interview, the staff person in charge stated that trash is being dumped over the fence onto the ground next to the playground space every day. She stated that this is done because the facility would smell bad if the trash was left inside all day. She stated that a staff person goes outside around mid day and then again at the end of the day to pick it all up and walk it over to the dumpster which is located at the back of the lot. On the day of the investigation there were a couple of empty boxes on the ground next to the playground.

922 KAR 2:120. Section 4. Premises Requirements.

(5) The building shall be constructed to ensure the:

(a) Building is:

- 1. Dry;
- 2. Adequately heated;
- 3. Ventilated; and
- 4. Well lit, including clean light fixtures that are:
 - a. In good repair in all areas; and
 - b. Shielded or have shattered proof bulbs installed; and

(b) Following are protected:

- 1. Windows;
- 2. Doors;
- 3. Stoves;
- 4. Heaters;
- 5. Furnaces;
- 6. Pipes; and
- 7. Stairs.

Findings:

General: Based on Observation, the temperature in the building on 10/25/17 was sixty-five degrees. The staff person in charge stated that the gas was shut off a couple of days ago because of a new restaurant being built next to their facility. She stated that the only gas they use at the facility is for heating the building so not until a couple of days ago was the heat turned on. She stated that everything else at the facility is operated by electric and the gas did not need to be turned on until recently due to the weather getting colder.
