General: Based on observation, during a tour of the child care center the surveyor found the following:

1. A twenty-three-month-old child (DOE: 09/17/14) was being provided care along with seven (7) two-year-old children. Through interview with a staff, the surveyor learned that the child is in the mixed-age group for longer than one (1) hour. The staff-to-child ratio was exceeded by two (2) children.




