General: Based on Observation and interview, Classroom #2 was over ratio by one (1) child. There were six (6) children and one (1) staff person present. The youngest child in the room was not quite one (1) year old.

Findings:

General: Based on Review of Documentation, it was found that five (5) staff files out of twenty-two (22) staff files reviewed did not have evidence of an annual evaluation. The director acknowledged this.



265 - Health, Safety, Comfort Not In Compliance

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.

- (1) Effective with the adoption of this administrative regulation, a director shall:
- (I) Provide for the health, safety, and comfort of each child;

Findings:

General: Based on Observation, there were were uncovered electrical outlets in Classroom #1, Classroom #11, Classroom #12, and the gym. Also, in Classroom #2 there was a child just under twelve (12) months old who was crying and laying on the floor. The teacher in this room picked the child up and told her she cannot go to sleep. This was observed for approximately ten (10) minutes and the infant continued to be fussy but was not permitted to nap. Also, in Classroom #2 there was a play yard type gate separating the changing area from the children's play area. The gate was not attached to anything but was propped against other furniture. It was not sturdy. In Classroom #12 and Classroom #13 there were large dry erase white boards propped against the walls. Finally, in Classroom #11 and Classroom #12 there were cribs turned onto the side and being used a play space for the children.

Findings:

General: Based on Review of Documentation, it was found that one (1) staff with a hire date of 04/06/2015 did not received a completed child abuse and neglect check until 04/21/2015. It was also found that three staff (3) with hire dates of 11/2015, 11/24/2015 and 12/09/2015 did not have evidence of a child abuse and neglect check. These staff were not found working alone. These instances are not in accordance with 922 KAR 1:470 which states that a request for a central registry check must be submitted within five (5) working days after the date of employment of an individual. It was found that a staff person hired on 02/09/2015 did not have evidence of a criminal records check until 04/06/2015. It was also found that seven (7) staff files did not have evidence of a criminal records check, the dates of hire for the staff were 10/05/2015, 07/06/2015, 10/05/2015, 01/06/2014, 11/2015, 11/24/2015 and 12/09/2015. These staff were not working alone with children. These instances are not in accordance with KRS 17.165 which requires that application for the criminal record of a probationary employee be made no later than the date probationary employment begins. The director acknowledged this.

General: Based on Review of Documentation, it was found that a staff person with a hire date of 07/06/2015, a staff person with a hire date of 10/05/2015 and a staff person with hire date of 11/2015 did not have evidence of proof of education. The director acknowledged this.

320 - TB Verification Not In Compliance

Findings

General: Based on Review of Documentation, it was found that employees with hire dates of 09/20/2013, 09/20/2013, 09/19/2014, 10/15/2015, 01/16/2014, 11/2015, 11/24/2015 and 12/09/2015 did not have evidence of a current statement indicating they were free of TB. The director acknowledged this.

It was also found that five (5) staff files out of twenty-two (22) staff files reviewed did not have evidence of the nine (9) hours of cabinet-approved early care and education training within the first year of employment. The dates of hire for these staff was, 12/01/2014, 02/11/2014, 10/20/2014, 09/19/14 and 09/12/2014. The director acknowledged this.
