- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of documentation, staff person hired 8/16/18 did not have evidence of completing the required orientation training in the first three (3) months of employment. A review of ECE-TRIS records supports the information found during the survey.

General: Based on observation, there was a large pair of adult scissors on a lower shelf behind the teacher's desk in the Threes & Fours classroom. The scissors were accessible to the children in care.

- b. Within thirty (30) minutes of arrival for school-age children;
- 2. Before and after eating or handling food;

Findings:

General: Based on observation, a child in the Threes & Fours classroom used the restroom and did not wash her hands afterwards. The child returned to Circle Tlme without washing her hands after toileting.

685 - Diaper Changing Area/Surface

- 6. Free of any items not used for diaper changing.

Findings:

General: Based on observation, the diaper changing mats in the Infant classroom and the Toddler classroom were covered with soft cloths. These surfaces were not non-absorbent and could not be properly disinfected between uses.
