Based on observation, there was one staff member standing at the doorway of the infant room. There were eight infants under the age of one-year-old. Three infants were in the back of the room down a hallway out of the scope of vision.

(b) The age of the youngest child in the group shall determine the:

- 1. Staff-to-child ratio; and**
- 2. Maximum group size.**

Findings:

General: Based on observation, the following was found:

1. There was one staff member standing at the doorway of the infant room. There were eight infants under the age of one-year-old. This exceeds the ratio by three infants with one staff.
2. There was one staff member with nine children aged one-year-old. This exceeds the ratio by three children for one staff member.
3. There were two staff members with 14 children ages 18 months to two-years-old. This exceeds the maximum number of children per staff member by two. In addition, the 14 children exceed the maximum group size of 12 children for this age group.

- 1. A statement from a health professional that the individual is free of active tuberculosis; or**
- 2. A copy of negative tuberculin results.**

General: Based on observation and review of documentation, staff with a hire date of 09/23/2019, did not have a physician's statement on file indicating they were free from TB.

922 KAR 2:120. Section 7. First Aid and Medicine.

- (6) Medication, including refrigerated medication, shall be:
 - (a) Stored in a separate and locked place, out of the reach of a child unless the medication is:
 - 1. A first aid supply and is maintained in accordance with subsection (1) of this section;
 - 2. Diaper cream, sunscreen, or toothpaste. Diaper cream, sunscreen, or toothpaste shall be inaccessible to a child;
 - 3. An epinephrine auto-injector. A licensed child-care center shall comply with KRS 199.8951 and 311.646, including:
 - a. An epinephrine auto-injector shall be inaccessible to a child;
 - b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
 - c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
 - d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 12(1)(b) if an epinephrine auto-injector is administered to a child; or
 - 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
 - (b) Kept in the original bottle; and
 - (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

Findings:

General: Based on observation, there were several packets of aspirin in the first aid kit that were not labeled with the name of an individual. Medication is to be stored in a separate, locked location that is out of the reach of children. Medication is also to be labeled with who the medication is for. A permission slip must be obtained that indicates how much and how often the medication should be facilitated.

- (1) A child-care center shall maintain:
 - (b) A written record for each child:
 - 1. Completed and signed by the child's parent;
 - 2. Retained on file on the first day the child attends the child-care center; and
 - 3. To contain:
 - a. Identifying information about the child, which includes, at a minimum, the child's name, address, and date of birth;
 - b. Contact information to enable a person in charge to contact the child's:
 - (i) Parent at the parent's home or place of employment;
 - (ii) Family physician; and
 - (iii) Preferred hospital;
 - c. The name of each person who is designated in writing to pick-up the child;
 - d. The child's general health status and medical history including, if applicable:
 - (i) Allergies;
 - (ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and
 - (iii) Permission from the parent for third-party professional services in the child-care center;
 - e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;
 - f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;

Findings:

General: Based on observation and review of documentation, a child with the enrollment date of 10/21/2019, did not have required physician's contact information.

General: Based on observation and review of documentation, although there was an emergency preparedness packet on file, there was not any proof indicating that it was received by emergency management officials.
