# Findings:

General: Based on Observation and Interview, the child care center failed to maintain adequate supervision in accordance with regulatory requirements. Observation of the preschool classroom revealed four (4) children with one (1) staff member in the blue room eating breakfast. Continued observation revealed one (1) child lying in the floor in the back room with a staff member sitting in the door way to the room. Further observation revealed one (1) staff member leave the blue room (stating she was taking a break), at which time the staff member sitting in the chair in the back room doorway, went into the blue room and served food to children sitting at the table. The staff member left the child in the back room out of the scope of vision for seven (7) minutes. The staff member then sat in a chair between the two (2) rooms supervising children. On two (2) more occasions she left the child in the back room out of the scope of vision for one (1) minute or less. Interview with a staff member revealed the ages of the children were three-year-olds and four-year-olds.

General: Based on Review of Documentation and Interview, the child care center failed to comply with regulatory requirements. Review of posted documentation revealed information concerning children with allergies was posted with no cover page. Review of children's files revealed the child care center failed to have a permission form to post allergies of aforementioned children. Exit interview with the director revealed unawareness that permission from parents must be obtained to post confidential information.

Continued observation of the electrical outlet revealed the left side and top of the cover plate for the electrical outlet was broken exposing the inside of the electrical box. Exit interview with the director revealed an acknowledgement of the deficient areas.
