General: Based on Observation, in the Twos classroom there was an uncovered electrical outlet and an outlet cover that was crooked. The crooked outlet plate left exposed wiring.

General: Based on Review of Documentation, 1. Staff person hired 9/25/17 did not have evidence of completing the required orientation training in the first three (3) months of employment. A review of ECE-TRIS records supports the information found during the survey. 2. Four (4) out of five (5) staff persons employed for more than one (1) year did not have fifteen (15) hours of annual training on file for the last full year of employment. A review of ECE-TRIS records supports the information found during the survey. 3. Four (4) out of five (5) staff persons employed for more than one (1) year did not have evidence of completing the Pediatric Abusive Head Trauma training within the first year of employment or once every five (5) years . A review of ECE-TRIS records supports the information found during the survey.

General: Based on Observation, there was a large roll of old chain-link fence, several fence poles with concrete footers and other old fence pieces with sharp metal edges lying on the facility's playground. In an interview with the Director it was stated that the fence had recently been replaced and the old fence and fence posts had not been removed from the playground.

General: Based on Observation, the ground cover under the playground structures used for climbing, sliding and swinging was very sparse and non-existant in places.
