(1) A child care provider shall maintain the employment or residential status of each child care staff member who has submitted to a fingerprint-based criminal background check by reporting the status using the NBCP web-based system.

Findings:

General: Based on Review of Documentation, it was found that the file for an employee hired on 4-9-18 did not contain evidence of the required background check being completed. It was later found that the employee had the background check completed under a sister facility, however, she was not listed in KARES as being an eligible employee under the facility being inspected as required.

Findings:

General: Based on Observation, it was found that a five-month-old child was sleeping in a bouncy seat in the Infant 1 classroom. The facility did not have written documentation stating that the child was required to sleep in this piece of equipment. In addition, it was found that a plunger in the Preschool bathroom was accessible to the children.

922 KAR 2:090. Section 11. Staff Requirements.

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
- 1. A statement from a health professional that the individual is free of active tuberculosis; or
- 2. A copy of negative tuberculin results.

Findings:

General: Based on Review of Documentation, it was found that the file for an employee hired on 10-19-16 contained the results of a TB skin test that was read on 9-30-15. This date is not within the two (2) year timeframe required by the regulation.

410 - Training Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 $\frac{1}{2}$) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on Review of Documentation, it was found that 1) the file for an employee hired on 1-6-14 contained evidence of only nine (9) hours of training being completed during the last completed training year; 2) the file for a second employee hired on 1-6-14 contained evidence of only fourteen (14) hours of training being completed during the last completed training year; 3) the file for an employee hired on 11-4-16 contained evidence of only six (6) hours of additional training being completed during the first year of employment; 4) the file for an employee hired on 10-19-16 contained evidence of zero (0) hours of additional training being completed during the first year of employment; 5) the files for employees hired on 5-26-16, 8-22-16 and 6-5-17 contained evidence of Pediatric Abusive Head Trauma training being completed on 2-27-13, 2-28-13 and 2-10-13. These dates are not within the five (5) year timeframe required by the regulation.

- (b) Kept clean and in good repair;

Findings:

General: Based on Observation, it was found that 1) the plastic outlet cover in the indoor gross motor room was broken on one (1) corner, creating a sharp edge; 2) rust stains from metal cabinets were found on the floors of the Toddler 1 classroom and the Pre-K Academy classroom; 3) the vent by the sink in the Montessori classroom was found to be rusting through the blue paint; 4) there was a very strong urine smell in the bathrooms located in the Preschool and Pre-K Academy classrooms.

580 - Floors, Walls, Ceilings Not In Compliance

922 KAR 2:120. Section 4. Premises Requirements.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on Observation, it was found that 1) the tiles on the floor by the sink and water fountain in the Pre-K Academy classroom were not laid properly. In two (2) places, there were one (1) foot by half inch gaps between tiles, exposing the subfloor; 2) a tile by the sink in the Pre-K Academy classroom was broken on the corner; 3) the vinyl flooring in the bathroom located in the Preschool classroom was found to be ripped and severely buckled behind the toilet. The buckling along a three (3) inch area raised the flooring approximately one (1) inch off the subfloor; 4) the wall by the art station in the Young Preschool classroom was found to be deeply gouged and pitted across a four (4) feet long section; 5) the wall above the baseboard near the sink located in the Montessori classroom was deteriorating and crumbling; 6) the carpet of the Montessori classroom was found to be running in a large T shape in the corner by the TV and the board games. The T shape was approximately three (3) feet by four (4) feet.

- (a) Be kept in clean condition;
- (b) Be kept in good repair;

Findings:

General: Based on Observation, it was found that the caulking around the bases of the toilets in the Preschool and Pre-K Academy classrooms was discolored to a dark yellow-orange color. The teachers stated that the discoloration most likely was the result of children urinating on the floor.

Findings:

General: Based on Observation, it was found that the sheets on two (2) of the crib mattresses in the Infant 1 classroom were very loose and wrinkled.

815 - Toys/Furniture Not In Compliance

922 KAR 2:120. Section 11. Toys and Furnishings.

- (1) All toys and furniture contacted by a child shall be:
- (a) Kept clean and in good repair; and
- (b) Free of peeling, flaking, or chalking paint.

Findings:

General: Based on Observation, it was found that 1) two (2) bucket seats in the Infant 2 classroom did not have the manufacturer required safety straps installed; 2) in the Toddler 1 classroom, the bottom of a metal cabinet was found to be rusting; 3) the paint on the side of the sink vanity in the Young Preschool classroom was found to be peeling; 4) the plastic coating on a white magnetic strip in the Varsity Club classroom was found to be peeling off. This strip is approximately three (3) feet from the floor. The children being cared for in the classroom during the survey were three to five-years-old.

Findings:

General: Based on Observation, it was found that the chains to the swings were rusting. The rust was found to easily rub off on skin when touched.

General: Based on Review of Documentation, it was found that the sign on and off logs for the field trips that occurred on 6-8-17, 6-28-17, 8-1-17 and 8-8-17 included only check marks, not the actual times each child got on and off the vehicle. In addition, the sign on and off logs for field trips that occurred on 6-16-17, 7-14-17 and 7-26-17 were unable to be located or reviewed.

Findings:

General: Based on Review of Documentation, it was found that one (1) child's file out of ten (10) children's files reviewed did not contain information regarding the parent's preferred hospital. It was also found that one (1) child's file out of ten (10) children's files reviewed did not contain a physician's telephone number.
