Findings:

General: Based on observation and interview, the following was found: (1) Two (2) electrical outlets located in the corner by the crib in the One's classroom did not have protective coverings. Upon interview staff reported all outlets are supposed to have protective coverings which should be replaced if the outlet is utilized. (2) One (1) electrical outlet in the reading area in the Pre-K classroom did not have a protective covering. Upon interview staff reported all outlets are supposed to have protective coverings which should be replaced if the outlet is utilized.

270 - Parent Notification

- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

305 - Background checks/discharged

- (c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
- (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
- (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
- (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.

Findings:

General: Based on review of documentation, review of ECE-Tris, and interview, the following was found:

(1) One (1) staff file presented for review (DOH: 3/18/14) only completed six (6) hours of annual training between 3/18/15 - 3/17/16. The staff's file did contain a CDA credential that they reportedly completed classes for between 3/18/15 - 3/17/16, however, the CDA certificate did not list dates that the classes were completed or provide credit hours earned. The director reported they had planned on the CDA class hours to count towards the staff's annual training hours.

(2) One (1) staff file presented for review (DOH: 10/16/14) only completed twelve and one half (12 1/2) hours of annual training between 10/16/14 - 10/15/15. The staff's file did contain a CDA credential that they reportedly completed classes for between 10/16/14 - 10/15/15, however, the CDA certificate did not list dates that the classes were completed or provide credit hours earned. The director reported they had planned on the CDA class hours to count towards the staff's annual training hours.

Findings:

General: Based on observation and interview, the following was found: (1) The lesson plan posted in the Two's classroom was not updated as the it was dated for 4/25/16 through 4/29/16. The classroom was not in use at the time of the survey but staff reported the classroom is used in the afternoons.

(2) There was no lesson plan posted in the Pre-K classroom which was being utilized. Staff reported they are not the regular teacher for the Pre-K classroom and was not aware of where the lesson plan would be.

(3) There was no lesson plan in the after school classroom. Staff in charge reported the after school teacher was supposed to bring the updated lesson plan back to the center after updating it but forgot it at home.

- (3) A pair of adult size tennis shoes were located in the floor next to the play kitchen. The shoes were accessible to the children. Upon interview it was determined the shoes belonged to staff.
- (4) A toilet cleaning brush and one (1) can of foaming bath cleaner were located on a shelf above the toilet in the restroom between the One's and Two's classrooms. The items were accessible to children. Upon interview staff stated the cleaning items are not supposed to be stored in the children's restrooms.
- (5) A pair of adult sized sandals were stored in the lower cubby of the changing table located in the Two's classroom. The sandals were accessible to children. Staff reported the sandals belonged to staff and that the Two's classroom is utilized in the afternoons.
- (6) A soiled rag was located on a shelf over the sink in the Pre-K classroom where it was accessible to children. Staff reported they must have forgotten to take the rag to the laundry.
- (7) A soiled rag was located on a shelf over the sink in the After School classroom where it was accessible to children. Staff reported they must have forgotten to take the rag to the laundry.

- (2) There was urine on the toilet seat and the toilet was not flushed in the restroom off of the Nursery classroom. Staff reported the Nursery classroom had not been utilized in at least a month, however, children do walk through the room to access the playground and sometimes utilize the restroom.
