Findings:

General: Based on Review of Documentation, and observation, the child care center failed to maintain adequate supervision in accordance with regulatory requirements. Review of staff files revealed a volunteer is contracted through Language Center, Inc. to assist with homework several hours a week. Additional review of staff records revealed an employee with the hire date of 9/5/14 was under the age of eighteen (18) years of age. Observation revealed that at approximately 4:15 p.m., two (2) other groups of children left with the adults in charge to wash hands for snack. Continued observation revealed the volunteer and the staff person under eighteen (18) years of age were left alone with twenty (20) children, ages five (5) years and older, until approximately 4:18 p.m., when the other two groups returned for snack.

General: Based on Review of Documentation, and observation, the child care center failed to comply with staffing requirements. Review of staff files revealed that employee with the hire date of 9/5/14 was under the age of eighteen (18) years of age and was not under the direct supervision of a qualified staff person, but rather, was working with a volunteer, supervising twenty (20) children ranging from kindergarten age to fifth grade students from approximately 4:15 p.m. to 4:18 p.m. in the cafeteria. Additional observation revealed that other groups of children returned with qualified staff to the cafeteria after washing hands for snack approximately three (3) minutes after leaving the group of twenty (20) children at a staff.


