Findings:

General: Based on observation and interview, the child care center failed to comply with staffing requirements. Observation of the K-1 group at 4:05 p.m. revealed thirty-four (34) children with two (2) staff members. Interview with a staff member revealed the youngest age child in care was five-years-old; therefore, the group was over ratio and maximum

group size. Observation of 2nd-3rd grade group revealed forty-four (44) children with two (2) staff members. Interview with a staff member revealed the youngest age child in care was sevenvears-old: therefore, the group was over the maximum group size.

(b) Shall provide, prior to employment and every two (2) years thereafter:

. A statement from a health professional that the individual is free of active tuberculosis; or

2. A copy of negative tuberculin results.

Findings:

General: Based on review of documentation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Upon request, written documentation from a health care professional was not presented for review to verify that a staff member with the hire date 10/24/16 was free from active TB.

410 - Training

922 KAR 2:090. Section 11. Staff Requirements.

(16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following: (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;

(b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and

(c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 1/2) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of documentation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of presented staff files revealed two (2) staff members with the hire dates 8/28/13 and 8/12/15 did not complete Fifteen (15) hours of cabinet-approved early care and education training. Review of the ECE TRIS report did not verify that the training hours had been completed. Interview with the director revealed she was not able to verify the training hours were completed.

Upon request, documentation was not presented to verify that a staff member with the hire date 9/04/09 had completed one and one half (1 ½) hours of cabinet-approved pediatric abusive head trauma training in the last five years.
