Findings:

General: Based on Review of Documentation, an employee with a hire date of 9/1/16 did not have results of an out of state background check in their personnel file. The staff person in charge stated that she did submit the paperwork for the out of state background check but did not recall getting any results back and could not show proof of those having been submitted.

General: Based on Review of Documentation, there were two employees both with hire dates of 9/1/16, who did not have proof of negative TB test results prior to their date of hire. The TB paperwork on file was dated for 10/11/16 and 10/15/16, which is after their dates of hire.
