Findings:

General: Based on review of documentation, the following issues were found:

- 1) The provider's (DOH 04/11/14) record presented for review did not contain evidence of the provider completing six (6) hours of cabinet-approved orientation in the first three (3) months of hire. During an interview with the provider, she stated that she had not yet completed cabinet-approved orientation.
- 2) The assistant's (DOH 04/11/14) record presented for review did not contain evidence of the assistant completing six (6) hours of cabinet-approved orientation in the first three (3) months of hire. During an interview with the provider, she stated that the assistant had not yet completed cabinet-approved orientation.

General: Based on observation, the temperature of the hot water supply was measured with a thermometer at one-hundred thirty (130) degrees Fahrenheit, exceeding the maximum allowable temperature of one-hundred twenty (120) degrees Fahrenheit.
