(I) Assure the health, safety, and comfort of each child;

Findings:

Observation of the three (3) and four (4) year old restroom revealed a ten (10) year old child was using the toilet room that did not contain a door or a barrier for privacy. The surveyor and individuals in the classroom could see inside the toilet room. Therefore, the school-age child did not have privacy.

General: Observation of the restroom door located in the four (4) and five (5) year old classroom revealed the restroom door was stained and had a dried substance on it.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Observation of the ceilings throughout the child care center revealed there were stained ceiling tiles, indicative of water damage, and there were several ceiling tiles that were not properly placed in the ceiling metal L-panel. Observation of the floors and walls revealed the floors had dust and debris with a build up of a dark black substance and the walls were stained with a dry black substance. In the younger one (1) classroom there was a baseboard torn and missing from the wall.

645 - Sink Not In Compliance

- (3) A sink shall be:
- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;

- (g) Immediately adjacent to a changing area used for infants and toddlers.

Findings:

General: Observation of the sinks in the boys' and girls' restroom located in the older three (3) year old classroom revealed the hot water in both sinks measured fifty-eight (58) degrees Fahrenheit.
