Findings:

General: Based on Observation, it was found that during the survey, one (1) staff person was supervising twelve (12) two and three-year-old children while they played on the playground. One (1) of these children was only twenty-six-months old, thus requiring the facility to abide by the ratios stated in 922 KAR 2:120. The group was out of ratio for approximately five (5) minutes while the second staff person was in the bathroom with two (2) other children.

General: Based on Review of Documentation, it was found that a staff person with a hire date of 07/27/2016 had no evidence of an out of state background check for the state of Ohio or evidence that one had been applied for. This staff has lived in Ohio within the past five (5) years.

General: Based on Review of Documentation, it was found that a staff person with a hire date of 10/01/2012 had no evidence of being free of TB. It was also found that a staff person with a hire date of 07/27/2016 did not have their TB skin test read until 10/23/2016.

340 - Training **Not In Compliance**

922 KAR 2:110. Section 5. Staff Requirements.

- (14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 1/2) hours of pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 $\frac{1}{2}$) hours of pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on Review of Documentation, it was found that a staff person with a hire date of 09/06/2016 did not have evidence of the six (6) hours of cabinet-approved orientation training within the first three (3) months of employment. A review of ECE-TRIS confirmed this.

General: Based on Review of Documentation, it was found that one (1) child's file out of ten (10) children's files reviewed did not contain a current immunization certificate.

General: Based on Observation, it was found that information regarding the Kentucky Consumer Product Safety Program and it's website was not posted in the facility. It was also found that a daily schedule was not posted in the Aftercare classroom. The schedule was found to be in a binder in a cabinet.
