Findings:

General: Based on Review of Documentation, one (1) staff file (hire date: 2/1/14) did not contain evidence of the six (6) hours of cabinet-approved orientation training being completed within the first three (3) months of employment. The staff person in charge presented a training certificate for this staff person during the survey that was dated 8/9/99 and indicated that it was for orientation training; however, the certificate did not reference the needed and required "Basic Health, Safety, and Sanitation" portion of the class to be accepted as cabinet-approved training.
