General: Based on observation, the surveyor discovered the following:

1. A toy truck was located under the sink in the restroom that was near the Early Head Start Classroom; therefore, the children's health and safety of the children could have been compromised by the toy truck being unsanitary in the restroom.

Staff reported that she was not sure why the toy truck was in the restroom but she would have it removed and cleaned.

2. A pacifier with a black and pink flamingo clip was found on a rug located in the play house center.

Staff reported that she would talk to staff about making sure pacifiers are put up when not in use.

#### Findings:

General: Based on observation in the Early Head Start Classroom, the surveyor found the following:

- 1. There was a blue rug located in the middle of the classroom that appeared to have dirt debris; therefore, the blue rug was not kept clean.
- 2. There was a rug located in the play house center that appeared to have dirt debris; therefore, the rug was not kept clean.

Staff reported that she would have the rugs cleaned.

### 625 - Floors, Walls, Ceilings

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

#### Findings:

General: Based on observation, the surveyor found that there was a ceiling tile located above the nursery that appeared to have a brown spot; therefore, the ceiling tile was not in good repair.

Staff reported that she would have the ceiling tile fixed.

General: Based on observation, the surveyor found what appeared to be toilet paper left in the toilet.

Staff reported that she would talk to staff to ensure the toilet is flushed after each use.
