General: Based on observation and review of documentation the child care center failed to maintain employee records in accordance with regulatory requirements. Based on observation a staff member with a hire date of 09/30/14 was the sold caregiver supervising twelve (12) children ranging in age from nine (9) years to eleven (11) years from approximately 3:00 P.M. to approximately 5:00 P.M. Based on a review of documentation, the staff member failed to have a completed background check contained in the personnel file.

Based on observation, a staff member with a hire date of 09/30/14 was the sole caregiver, supervising a group of twelve (12) children ranging in age from nine (9) years to eleven (11) years. Based on a review of documentation, a completed background check was not available for review.
