General: Based on review of documentation and interview, the child care center failed to comply with background checks in accordance with regulatory requirements. Review of the KARES report revealed three (3) individuals listed as current employees who were determined to eligible for employment on 10/23/18, 10/3/18 and 8/12/19. Interview with the staff member in charge revealed that the aforementioned individuals were no longer employed with the child care center.

Upon request, the staff member in charge did not present a current evaluation for the aforementioned staff members at the time of the survey.

Findings:

General: Based on review of documentation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of the presented employee records revealed that the files were not maintained for three (3) staff members with hire dates 9/15/17 and 8/2/19. Verification of completed background checks were not presented for review for the aforementioned staff members. No documentation was provided for review for the two (2) staff members with the same hire date of 8/2/19. Upon request, the staff member in charge did not provide documentation for the aforementioned staff members at the time of the survey.

General: Based on review of documentation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of the presented employee records revealed files were not presented for review for two (2) staff members with the same hire date of 8/2/19. Upon request, the staff member in charge did not present educational documentation for the aforementioned staff members at the time of the survey.

395 - TB Verification Not In Compliance

- (b) Shall provide, prior to employment and every two (2) years thereafter:
- 1. A statement from a health professional that the individual is free of active tuberculosis; or

Findings:

General: Based on review of documentation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of the presented employee records revealed files were not presented for review for two (2) staff members with the same hire date of 8/2/19. Review of the presented employee records revealed three (3) staff members with hire dates 9/15/17, 2/9/16 and 10/27/17 whose file did not contain a current statement from a health professional that each staff member was free of active tuberculosis. Upon request, the staff member in charge did not present a current statement from a health professional verifying that the aforementioned staff members were free of active tuberculosis.

General: Based on review of documentation and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of the presented employee records revealed two (2) staff members with hire dates 9/15/17 and 2/9/16 whose file did not contain documentation to verify completion of the fifteen (15) hours of cabinet approved training. Review of ECE-TRIS verified that the staff members did not complete the fifteen (15) hours of cabinet approved training. Upon request, the staff members in charge did not present training documentation for the aforementioned staff members at the time of the survey.

General: Based on review of documentation and interview, the child care center failed to maintain children's records in accordance with regulatory requirements. Review of the presented children's records revealed three (3) children with enrollment dates 7/5/19, 6/7/19 and 4/19/18 whose file did not contain a current immunization certificate. Upon request, the staff member in charge did not present a current immunization certificate for the aforementioned children at the time of the survey.

1140 - Enrollment Information Not In Compliance

- (1) A child-care center shall maintain:
- (b) A written record for each child:
- 1. Completed and signed by the child's parent;
- 2. Retained on file on the first day the child attends the child-care center; and

- (i) Parent at the parent's home or place of employment;

- e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;
- f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;

Findings:

General: Based on review of documentation and interview, the child care center failed to maintain children's records in accordance with regulatory requirements. Review of the presented children's records revealed a child with enrollment date 8/5/19 whose file did not contain the name of the family's preferred hospital. Upon request, the staff member in charge did not present the documentation for the aforementioned child at the time of the survey.


