General: Based on Review of Documentation, and ECE-Tris records there was one (1) staff person hired as a substitute 8/15 who only had evidence of having completed 9.5 hours of cabinet approved training for the 2015-2016 training year.

## 922 KAR 2:110. Section 5. Staff Requirements.

- (14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1  $\frac{1}{2}$ ) hours of pediatric abusive head trauma training; and

General: Based on Review of Documentation, and ECE-Tris records there was one (1) staff person with a hire date of 7/9/14 who only had evidence of having completed thirteen (13) hours of cabinet approved training for the 2015-2016 training year.

### Findings:

General: Based on Observation, it was found that parents and staff enter the home through a set of French doors located at the front of the home. This entrance opens up into the space used for the infants and toddlers. You then walk through this area to access the preschool room. During an interview with the staff person in charge it was indicated that she can start asking parents to enter through the door at the back of the home which opens into the preschool room. At the time of the survey there were no signs or any indication that everyone should enter through the back door.

  - b. Contact information to enable a person in charge to contact the child's:
  - (i) Parent at the parent's home or place of employment;

General: Based on Review of Documentation, there was one child's enrollment information that did not include the child's physician's name and number.

General: Based on Observation, it was found that the current rates for child care were not posted, During an interview with the staff person in charge it was indicated that they had removed postings from the walls in order to paint and the rates had not been put back on the wall.
