General: Based on Observation, this regulatory requirement was not met. The surveyor observed one (1) staff person (hire date: 8/21/14) caring for twenty-one (21) school age children (1st - 5th graders) from 3:40PM - 3:45PM and twenty-two (22) children in the same age range from 3:45PM - 4:15PM in Room 202. The youngest child in the group was six (6) years old; therefore, minimum staff to child ratio would need to be one (1) staff person for fifteen (15) children.
