(3) An animal that is considered undomesticated, wild, or exotic shall not be allowed at a child-care center unless the animal is: (a) A part of a planned program activity lead by an animal specialist affiliated with a zoo or nature conservatory; and (b) In according with 2014 KAB 2:021 and 2014 KAB 2:022	

(b) In accordance with 301 KAR 2:081 and 301 KAR 2:082.
