Findings:

Four Year Old Classroom: Based on observation, two (2) classroom staff were seated in the front area of the classroom. Observation revealed neither staff was able to see children playing in the block center located in far corner of the of the "L" shaped classroom. Additional observation revealed a textile room located off of the bottom of the "L" shaped room and children were observed playing in the textile room unsupervised. Additional observation of the textile room revealed an unlocked closet that children have access to that leads outdoors.

Three Year Room: Based on observation, at 10:45 a.m. a female child was observed in the bathroom, located approximately ten (10') feet down the main hallway, alone without supervision. Continued observation revealed the child returned to her classroom which was located at the end of the hallway, approximately ten (10') feet away.
