<b>Findings:</b>	
<p>General: Based on Interview, it was found that a four-year-old child was left in the classroom while the rest of the children were taken to breakfast in another part of the school. The incident occurred on April 4, 2018. The staff person responsible for the child indicated that when she came into the classroom that morning, the staff in the classroom told her about the four-year-old asleep in the quiet area and then left the children in her care. At approximately 8:25am the staff person took the children to breakfast in another room. The children returned to the classroom at approximately 8:45am. At that time a child alerted the staff that the four-year-old was still asleep in the quiet area.</p>
