(16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following: (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;

(b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and

(c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and onehalf (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

### Findings:

General: Based on review of documentation presented and ECE-TRIS, the surveyor found that staff (DOH: 07/28/10) obtained thirteen and one half (13 1/2) of the required fifteen (15) hours of cabinet - approved early care and education training.

During interview, staff stated that they were not aware of training hours being short.

### Findings:

General: Based on observation during a tour of the childcare center, the surveyor found the following:

1. There were brown circular stains on the ceiling tiles located in the hallway outside the classrooms.

2. There was a brown circular stain on the ceiling tile above the sink in Classroom 310.

3. There were stains on the ceiling tiles above the science bookcase in Classroom 310.

4. There were water stains on the ceiling tiles located at the entrance of Classroom 310.

5. There was a stain on a ceiling tile located at the entrance of Classroom 308.

6. There were water stains on the ceiling tiles located above the kitchen play set in Classroom 308.

7. There were water stains on the ceiling tiles located by the water table in Classroom 308.

Staff stated during interview that the ceiling tiles would be repaired.
