Names a director, employee, volunteer, or person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care as the alleged perpetrator; or (f) An individual specified in Section 6(4) of this administrative regulation meeting a disqualifying criterion or background check result pursuant to 922 KAR 2:280.

#### Findings:

General: Based on interview, the center did not notify the Division of Regulated Child Care (DRCC) of a report of child abuse that was accepted by the Department for Community Based Services which named an "unknown" caregiver as the perpetrator. The center was made aware of the abuse investigation on 01/10/22, and an outside caller notified DRCC on 1/11/22.
