- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.
- (17) A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.

Findings:

General: Based on review of documentation, the following was found;

- 1) Staff hired on 05/01/2006, 06/10/2019, 01/20/2021, and 02/01/2021, did not complete the required fifteen (15) hours of cabinet approved training for the July 1, 2020 to June 30, 2021 year.
- 2) Staff hired on 02/01/2021, did not complete the required Pediatric Abusive Head Trauma training. This staff member has been employed for more than a year.

The ECE-TRIS system was reviewed and confirmed these findings.
