General: Based on interview and review of documentation, a staff, hired on 01/14/19; a staff, hired on 01/06/19, and a staff, hired on 03/12/19, did not have education verification on file

General: Based on interview and review of documentation, a staff, hired on 10/09/18, had TB documentation on file that was dated 10/18/16. A staff, hired on 03/12/19, did not have TB documentation on file

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;

General: Based on review of documentation, a staff, hired on 02/05/18, completed eight and a half (8 ½) hours of cabinet approved training during the first year of employment. A staff, hired on 12/15/14, completed fourteen (14) hours of cabinet approved training hours during a subsequent year of employment. A staff, hired on 12/15/14, completed thirteen and a half (13 ½) hours of cabinet approved training hours during a subsequent year of employment.

General: Based on observation, the daily planned program of activity was not developed in the younger infants' room. The daily planned program of activity was not posted in the older infants' room.

General: Based on observation, several wadded up plastic bags were stored in an unlocked cabinet in the preschool room. These were not a part of the planned program of instruction and were accessible to children.

General: Based on observation, a caregiver failed to wash her with liquid soap and warm running water after she wiped a child's nose in the younger infants' room. A caregiver failed to wash her with liquid soap and warm running water after she wiped a child's nose in the one-year-olds' room.

685 - Diaper Changing Area/Surface

- (b) Be placed on a surface that is:

- 5. Easily cleaned; and
- 6. Free of any items not used for diaper changing.

Findings:

General: Based on observation, the inner seams were exposed on the diapering surface in the two-year-olds' room.

- (6) Medication, including refrigerated medication, shall be:
- (a) Stored in a separate and locked place, out of the reach of a child unless the medication is:
- 1. A first aid supply and is maintained in accordance with subsection (1) of this section;
- 2. Diaper cream, sunscreen, or toothpaste. Diaper cream, sunscreen, or toothpaste shall be inaccessible to a child;
- 3. An epinephrine auto-injector. A licensed child-care center shall comply with KRS 199.8951 and 311.646, including:
- a. An epinephrine auto-injector shall be inaccessible to a child:
- b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
 - c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
- d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 12(1)(b) if an epinephrine auto-iniector is administered to a child: or
- 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

General: Based on observation, a bottle of children's Tylenol and a tube of Clotrimazole cream were each stored unlocked in a child's cubby in the one-year-olds' room. A bottle of sunscreen was stored unlocked in the top section of a child's cubby in the preschool room. A bottle of children's pain and fever syrup was stored unlocked in a cabinet in the twovear-olds' room.

General: Based on observation, two (2) red and blue nap mat were torn and had foam exposed in the one-year-olds' room.

(6) Cots, equipment, and furnishings used for sleeping and napping shall be spaced twelve (12) inches apart to allow free and safe movement by a person.

Findings:

General: Based on observation, an infant slept in a crib positioned approximately an inch from a shelf. Also, an infant slept in a crib that was eight (8) inches from another crib in the vounger infants' room.

- (c) Be forty (40) degrees Fahrenheit or below.

Findings:

General: Based on observation, a working thermometer was not in the refrigerator in the younger infants' room. A working thermometer was not in the refrigerator in the kitchen.



1050 - Bottles Not In Compliance

922 KAR 2:120. Section 8. Kitchen Requirements.

- (9) Bottles shall be:
- (a) Individually labeled;
- (b) Promptly refrigerated;
- (c) Covered while not in use; and
- (d) Consumed within one (1) hour of being heated or removed from the refrigerator.

General: Based on observation, two (2) bottles were not labeled in the younger infants' room.

General: Based on review of documentation, a child, first date of attendance on 08/13/18, did not have the name of each person who was designated in writing to pick-up the child.
